Any possession claim with a hearing already listed requires a reactivation notice to be filed and served at least 42 days before the hearing – Practice Direction 55C 2.5. The notice itself says. You are required to set out the knowledge you have as to the effect of the Coronavirus pandemic on the Defendant and their dependants.

Possession proceedings rules applicable to repossession of rented properties. Family intervention tenancies. A landlord does not have to prove any grounds for possession and the county court must order possession if it has followed the correct procedure to end the tenancy of a family intervention tenant.
